# ED.M. IN SPECIAL EDUCATION WITH ADVANCED CERTIFICATION: TEACHER OF STUDENTS WITH DISABILITIES (TOSD)

Revised April 2025 - for students admitted for fall 2025 or later

## I. PROGRAM DESCRIPTION:

The Ed.M. in Special Education with Advanced Licensure: Teacher of Students with Disabilities (TOSD) offered at the GSE provides advanced preparation for certified teachers who wish to teach students with special needs.

The Ed.M. is intended for educators who already hold a New Jersey Standard Instructional Certificate or a Certificate of Eligibility with Advanced Standing (CEAS) and wish to gain advanced licensure as a Teacher of Students with Disabilities. This advanced degree program does not lead to initial teacher certification.

Candidates in this program take required coursework that leads to New Jersey Department of Education certification as Teacher of Students with Disabilities within an elementary or secondary school setting.

Through completion of the required courses, students will develop knowledge, and competencies in inclusive education, assessment, intervention, data-based decision making, teaching, collaboration, related social issues, consultation, instructional technology, and New Jersey Special Education Law, balancing wellness promotion and risk-based prevention approaches for diverse group of learners.

## II. APPLICATION DEADLINES:

Fall admission - February 1 deadline Spring admission - October 15 deadline Summer admission - May 15 deadline

- **III. APPLICATION REQUIREMENTS:** To be considered for admission to the program, applicants must provide the following before the deadline:
  - 1. An electronic copy of a New Jersey Standard Instructional Certificate or a Certificate of Eligibility with Advanced Standing (CEAS) showing certification other than English as a Second Language.
  - 2. Personal statement
  - 3. One letter of recommendation\*
  - 4. Official undergraduate transcripts

\*NOTE: The recommendation requirement is waived for any applicant who has successfully completed at least 15 credits, with a B+ average, in the non-degree graduate certificate for advanced licensure in special education program.

- IV. HOW TO APPLY: Applications are submitted online at the Graduate Admissions website: <a href="https://newbrunswickgrad.rutgers.edu/">https://newbrunswickgrad.rutgers.edu/</a>
  - 1. Click on "Create Account or Login" and follow the instructions given.
  - Under "Start an application today!", click Apply Now Application Selection
  - 3. For "Level of Application", select Graduate
  - 4. For "Applicant Type", select Degree
  - 5. Continue filling out the application, following the on-screen instructions.

- 6. Under "Program Information", make sure **Degree** is selected for "Applicant Type"
- 7. For "Degree Type", select Master's (e.g. MA, MS, EdM, MFA)
- 8. For "Area of Study", select **Education**
- 9. For "Location/Instructional Method", select **New Brunswick**
- 10. For "Program Selection", select **Education Special Education (EDM) New Brunswick**<u>Program Details</u>
- 11. For "First Preference Concentration", select **Teacher of Students with Disabilities**. (2nd and 3rd preferences can be left blank.)
- 12. Complete the rest of the application by providing the requested information.
- 13. Enter payment information for the non-refundable application fee.
- 14. Submit your application.

**NOTE:** If a student uses a course or courses from their undergraduate career, 5-year, or post-baccalaureate initial certification program to substitute for required courses, then the student will need to take courses in its place to complete this degree program with 36 earned credits.

- VI. PORTFOLIO: Students will archive artifacts from various GSE courses via an online instructional and evaluation system as directed by faculty.
- VII. HIB TRAINING: All candidates for certification must complete pre-service training in the prevention of harassment, intimidation, and bullying (HIB)
