

Does American Allow You to Hold Flights Booked Within 24 Hours of Departure?

American Airlines Group, Business Travel, Multi-City, and Last-Minute Booking Process

Group reservations, corporate business travel bookings, multi-city itineraries, and last-minute ticket purchases on American Airlines each operate under a separate set of rules from standard individual bookings. Group fares require bulk seat allocation, deposit payments, and name submission timelines. Business travel tickets must apply corporate account credentials to qualify for managed fare benefits. Multi-city itineraries combine multiple independent segments into a single booking transaction. Last-minute purchases are subject to strict booking cutoffs that vary by route and fare class. Each of these booking types can be completed through agent-assisted channels when the standard online flow cannot handle the transaction.

- **Group Booking Process — 10 or More Passengers:** Group reservations on American Airlines for parties of 10 or more passengers access dedicated group fares with flexible name submission timelines and deposit-based payment schedules. A deposit secures the seat block while passenger names and final payment are finalized — typically within a set window before departure. Group holds and fare locks protect the bulk pricing during this period.
